Additionally, some flag states may offer lenient taxation policies or other incentives that attract shipowners seeking to minimize operational costs, even if it means operating under less stringent regulatory environments. Consequently, this can create a favourable environment for illicit operators to exploit the maritime domain and engage in nefarious activities, posing significant challenges for international law enforcement and efforts to combat illicit trafficking. To address these issues effectively, greater cooperation and stringent international oversight are essential to ensure that flag bearers uphold high standards of maritime governance and accountability.
